If this application is accepted and approved by the Board of Directors, I agree to abide by the rules and regulations set up for the governing of the Golf & Country Club. Failure to abide by the Club's rules shall subject the Applicant to suspension or termination. Upon suspension or termination during the first year, Applicant shall be responsible for the balance of the annual dues.

This club does not discriminate on the basis of race, color, sex, religion, national origin, handicap or age with regard to membership.

It is understood and agreed that all dues are payable in advance, and that membership in the Club is continuous, except that membership may be terminated upon 30 day's written notice by either the Applicant or by the Golf & Country Club, after the first or second year (depending on contract above). If membership is terminated by Minnesott Golf & country Club or the applicant after the contract year, the balance of any advance dues shall be refunded to the Applicant.

Military Clause: If we are presented a copy of orders involving relocation of military personnel, the member will not be held responsible for the remainder of the contract as of the date to report to the new location. Monies owed will be prorated to that day or a refund will be issued.

Payment Options The initiation fee is due with the membership application by cash, check, Visa, or MasterCard. The first months dues are payable with the membership application by cash, check, Visa, or MasterCard. Monthly dues are payable by Cash, Check, Bank draft, debit or credit card. We recommend setting up a Club Account with either a Credit Card or Bank Draft. Payment of dues in advance until the end of a calendar year are also accepted and for such a discount equal to 3% of the dues will be given.

Family Golf MEMBERSHIP

Unlimited use of all Golf and Social facilities by Primary, Co, and Dependent family members, one vote per membership at the annual meeting, unlimited greens fees, free range balls for member & guest. (Guest golf fees apply).

Primary member eligible to hold office on the Board of Directors.

Annual Dues: \$2400 or (\$200 per month) (less 3% = \$2328.00 if paid in advance)

Individual Golf Plus MEMBERSHIP

Unrestricted use of all Golf and Social facilities by the Primary member, one vote at annual meeting, unlimited greens fees, , free range balls for member & guest, eligible to hold office on the Board of Directors, with Social Membership only for Co and Dependent family members (Guest golf fees apply).

Annual Dues: \$2316 or (\$193 per month) (less 3% = \$2246.52 if paid in advance)

Individual Golf MEMBERSHIP

Unrestricted use of all Golf and Social facilities by the Primary member, one vote at annual meeting, unlimited greens fees, free range balls for member & guest, eligible to hold office on the Board of Directors, No family access except as a guest of the Primary member, guest rules and fees apply to all.

Annual Dues: \$2208 or (\$184 per month) (less 3% = 2141.76 if paid in advance)

Young Adult/Family Golf MEMBERSHIP

Young Adult/Family Golf Membership – This membership applies to person or persons and their partner or spouse who are both under the age of 39. Rights and privileges of Young Adult/Family memberships are the same as that of a “Family Golf Membership” except that such members must be 21 years old or older in order to have voting rights and hold an elective office. This special membership program is a 2-year membership commitment with a one-time \$100 initiation fee. (Guest golf fees apply).

Annual Dues \$900 or (\$75 per month) (less 3% = \$873 if paid in advance)

Social MEMBERSHIP

This membership is intended for persons who do not plan to make regular use of the golf facilities. Social Membership provides unlimited use of all MG&CC Golf and Social facilities for the Primary Member and Co-Member, and the named dependents. Use of the golf facilities require payment of “Social Member” green and cart fees. A social member has no vote; however, a maximum of one (1) seat on the Board of Directors may be held by a Social member. (Guest golf fees do not apply to Social Memberships)

Annual Dues: \$720 or (\$60/month) (less 3% = \$698.40 if paid in advance)

Note: Dues are payable in advance yearly or on the 1st of each month. It is each member’s responsibility to pay in a timely manner. Make checks payable to: Minnesott Golf & Country Club, P O Box 188, Arapahoe, NC 28510 or set up in the office a Club Account. **LOCAL RESIDENT RULE:** Persons defined as “local residents” in the Rules & Regulations may use the golf facilities only twice per year unless they are a spouse or dependent of a member, at which time they will be required to become a member if they wish to continue to use the facilities. Exceptions may be made when the club is running special programs.
